The recent cases won by the multidisciplinary team of lawyers from Reff & Associates | Deloitte Legal and the tax advisors from Deloitte Romania include a favorable decision for the taxpayer on VAT at the <u>Court of Justice of the European Union in a dispute with the Romanian fiscal authority</u>, which it is mandatory and has become a reference throughout the European Union in terms of the conditions regarding the fixed establishment. Also, the multidisciplinary team obtained, at the <u>High Court of Cassation and Justice (ÎCCJ)</u>, an important solution to <u>cancel EUR 5.5 million tax decisions</u> issued by the tax authority to a support services company, member of a group operating in the energy field. Another <u>final solution obtained by the multidisciplinary team at the ÎCCJ required the tax authority to motivate the application of a transfer pricing method different from the one chosen by the taxpayer and confirmed that the tax authorities must thoroughly justify the reasons for applying a certain</u>

method of transfer pricing.
