Senate defeats ordinance on national interests

At a plenary sitting on Wednesday, the Senate defeated a bill initiated by the government to amend a law on measures to protect national economic interests to replace "shareholdings" with "shares."

The bill was voted down 70 to 30 and and 21 abstentions.

The Senate is the first chamber notified about the bill.
