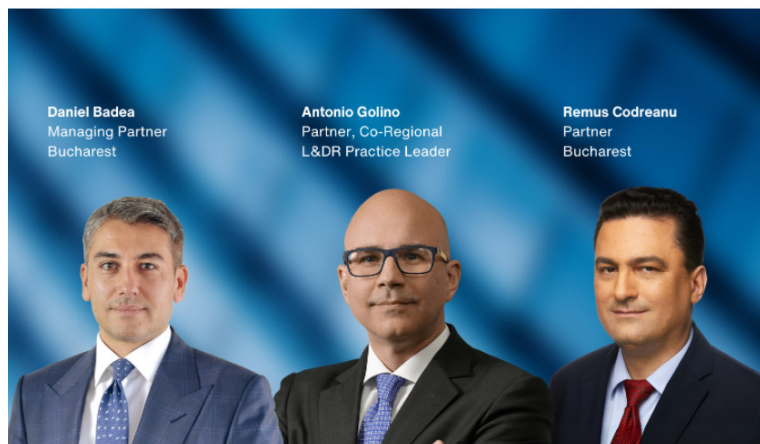


## Clifford Chance strengthens Litigation practice with addition of Remus Codreanu as Partner in its Bucharest team
